

**CITY OF LAKEVIEW
BAXTER COUNTY ARKANSAS
ORDINANCE 21-02**

**AN ORDINANCE TO CHANGE THE ZONING OF CERTAIN LANDS WITHIN THE
CITY OF LAKEVIEW, BAXTER COUNTY, ARKANSAS.**

WHEREAS, a petition was presented to the City of Lakeview to rezone certain properties identified as 5351 St. Hwy. 178 containing 43 acres m/l from R-1 Residential to A-1 Agricultural; and

WHEREAS, the Planning & Zoning Commission held a public hearing to receive public input as to the pros and cons of granting said request; and

WHEREAS, upon further investigation it was recognized that the 500 foot portion of the tract, immediately adjacent to St. Hwy. 178 was reserved for C-2 Commercial; and

WHEREAS, petitioner has modified his original request such that the portion of land identified for C-2 Commercial be included in the original request and added to the request for A-1 Agricultural; and

WHEREAS, the Planning & Zoning Commission has recommended that the request as amended be granted.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Lakeview, Baxter County, Arkansas that the property identified above as per the plat and legal description attached hereto and made part hereof, be rezoned from R-1 Residential and C-2 Commercial to A-1 Agricultural.

SEVERABILITY – The invalidity or unconstitutionality of the provisions of this Ordinance shall not affect any other section hereof, but shall remain in full force and effect.
