# CITY OF LAKEVIEW BAXTER COUNTY ARKANSAS ORDINANCE 24-02

AN ORDINANCE VACATING PORTIONS OF THE RIGHT OF WAY DESCRIBED AS THE CUL-DE-SAC PORTION OF NOTTINGHAM DRIVE WITHIN THE DEVONSHIRE SUBDIVISION, CITY OF LAKEVIEW, BAXTER COUNTY, ARKANSAS.

WHEREAS, William Ishmael petitioned the City of Lakeview to review the necessity of retaining the cul-desac at the end of Nottingham Drive, Devonshire Subdivision with the intent of vacating the right of way for said cul-de-sac; and

WHEREAS, after review by the Lakeview Planning and Zoning Commission has determined that said abandonment has no adverse effect in that it only effects the two properties adjoining the cul-de-sac; and

WHEREAS, after further review the Lakeview Planning and Zoning Commission recommends that the request be granted and that the portions of right of way as vacated per the Certified Survey Map, copy attached, be affixed to the two properties in question.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Lakeview, Baxter County, Arkansas that said City releases, vacates and abandons all its rights in and to the right of way described herein, and

**3E IT FURTHER ORDAINED** that a copy of this ordinance shall be filed with the Baxter County Clerk; Baxter County Assessor; Baxter County Surveyor and recorded in the Deed Records of Baxter County.

SEVERABILITY – The invalidity or unconstitutionality of the provisions of this Ordinance shall not affect any other section hereof, but shall remain in full force and effect.


