A. State Aid Street Program

1. Mayor Behling stated that he received a letter in the mail today from AR DOT that there is a meeting scheduled on March 4, 2025 at 2:00 PM in Yellville. There are currently four local cities in this contract that Atlas Asphalt is the contractor for. Mayor Behling indicated that the city has paid in full the bill to Atlas Asphalt, but there may be some overages which will need to be covered in the future, if necessary.

- A. Council Opening
- 1. Mayor Behling stated that a vacancy in Ward 3 Position 2 former Cncl. Newell's district is currently available. Mayor Behling stated that it is the responsibility of the City Council to elect someone for the unexpired term. Four individuals in the Ward area were mentioned as possible interested candidates. Cncl. Reubin suggested that the city invite the interested candidates to the next city council meeting on March 18, 2025 to start the process of filling the vacancy.
- B. Arkansas Legislature-Short Term Rentals
- 1. Mayor Behling informed the city council that there is a bill in the House (Bill 1445) regarding short rentals. Mayor Behling stated that he would keep the city council abreast of future developments in the Arkansas Legislature.
- C. Sinkhole on Dogwood
- 1. Mayor Behling stated that the sinkhole on Dogwood is growing. Billy Wehmeyer from Consolidated Land Services, Inc. came out to look at the sinkhole along with employees from the City of Lakeview. Mr. Wehmeyer stated that he would assist the City of Lakeview into requesting the service of a geological company so that the city can get a clearer picture of the current situation and how to mitigate it. Mayor Behing stated that the City of Lakeview will block off the south side of Dogwood to a one-way traffic flow. Mayor Behling also stated that the city will get ahold of a tree service to remove some trees in that area and will contact Lakeview Midway Public Water regarding water lines in this area.
